Public Comments:

A resident needs contacted to verify if they have moved out of town or not as the property could be considered abandoned and the water may need to be shut off.

Drainage concerns were brought to the City's attention from the King Family and Miller Family.

A concern was brought to the Mayor's attention about the location of a camper and where it is parked.

A concern about a resident's dog for excessive barking was mentioned to the Mayor.

The City received a concern about New Cooperative and their clean up after loading rail cars and etc. The wind carries the grain / grain dust throughout town. New Cooperative was contacted and it was recommended they be more proactive in cleaning it up more often.

Water / Sewer Report:

Craig Larson for the month of March 2020. 335.0 thousand gallons were pumped to the tower and 0.857 million gallons were pumped to the ponds. Did a pre - draw down sample, it came back good. Have begun doing the draw down. Finishing up fixing the aerator, replaced one encoder. Have had some drainage work and jetting of tiles completed around town. Clean outs were put in some tile, jetted all intakes along the main street and east of main street. Some may need repair. 16,500 gallons were used to back flush. Called Craig Larson at 6:55 pm and put on speaker phone to inquire about Chlorine Tank at water plant. The tank is leaking, have a new one on order and will install it soon. Ended called at 6:57 pm with Craig Larson.

<u>Community Hall Rental Fees:</u> As there has been a flat fee for all community hall rentals it was decided to review and update the list of events and costs for holding events at the community hall. Upon discussion the council approved the rates below.

<u>Drainage NW/NE sides of town</u> - The Mayor spoke with Craig, Water Superintendent, and it was decided to go forward with general maintenance of jetting / cleaning out the drain tiles / intakes in town to help with the flow of storm water. Al Price and Gudmonson's were contacted to do this and also Nels Pederson Co was contacted to complete tile repairs, grade and excavate problem areas that had standing storm water.

The Mayor contacted Nels Pederson Co to get an estimate for the drainage issue on the NE side of town to take the water to the county tile located East of Vincent.

<u>Water Tower Antenna Install Update -</u> The City Clerk reached out to Verizon to inquire on the status of the antenna install. The City Clerk received the paperwork and will be mailing it out this month, should see the install start in May.

<u>Streets</u> – Corner of 3rd Street and Marshall; needs looked at and possibly fixed. Will be looking into recoating streets.

<u>Parks</u> – The City Clerk received bids for the park shelter repair, will be putting in fill dirt for the low lying areas and also planting grass seed.

<u>Waste Management</u> – The COO and manages decided to close the landfill for residential dumping. This is to keep all employees safe during the COVID-19 Virus and also abiding by the CDC recommendations.

<u>Fire</u> – Fire Chief Miller is in contact with the Webster County EMA team each Wednesday for updates on COVID-19. Ordering and getting the needed PPE for EMS and following recommended protocols when called out.

<u>Community Hall</u> – The west door got replaced and all rentals are on hold til Governor Reynolds lifts the ban on gatherings. Updated rental fees.

<u>Mayor</u> – Worked with Nels Pederson Co for water drainage maintenance, sent out e-mails to council regarding drain tiles and approval to clean them out and update on progress. Contacted Craig Larson to contact contractors to bid on cleaning out tiles professionally. Contacted Scott with Nels Pederson Co to work on excavating and grading to help with water flow in town, contacted affected residents before Scott began this project. Spoke with city attorney in regards to drainage maintenance, COVID-19 and also update on letter mailed to the railroad in regards to the ditch that was trenched out on the North side of the tracks. Contacted the City Clerk on March 16, 2020 to close the City Hall to the public and also to type a COVID-19 response to the community and post it accordingly. Emailed in response to utility billing to continue on as per City Ordinance states and also Governor Reynold's recommendation from 3/20/2020 and sent out a Confidential Covid 19 email.

<u>Clerk</u> – Mailed nuisance abatement letters, Contacted Mike Johnson regarding the city insurance policy, Contacted contractors for vegetation control 2020 bidding, contacted ISG for city capital improvement plan, contacted Verizon for antenna install update on the water tower, contacted Tony Axtell for repair of community hall west door, contacted MSE for water plant camera install, contacted contractors for sidewalk repair at city hall and park shelter repair, reviewed city petty cash policy, working on recommendations from the last city audit that was completed, submitted FY '20-'21 budget, rec'vd ICAP grant monies, reached out to begin process for water source protection plan per DNR recommendation, received building permits from residents and working on updating the city website.

<u>Public Comments</u> - It was mentioned to post signs at the city park for closures and etc.instead of only at the 3 designated posting sites in town.
